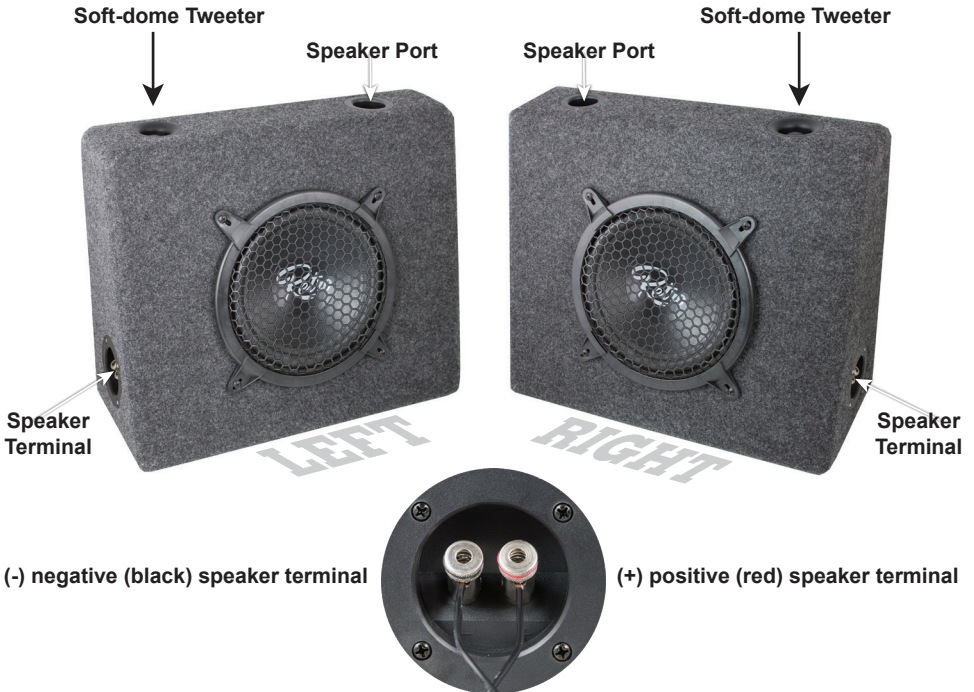
The two R-TB8 Full-Range Speaker Boxes are a mirror image of each other, one for the passenger's side and one for the driver's side. Each enclosure contains an 8" subwoofer, soft-dome tweeter, and connecting terminal.

Installation

Securely mount the enclosures in your vehicle to avoid damage or injury. Before mounting the enclosures, make sure the speaker ports and soft-dome tweeters are not obstructed and the speaker terminals are accessible. The speaker terminals are designed to accept speaker wire by pushing the terminal inward and inserting the wire. Connect the positive speaker wire to the positive (red) speaker terminal. Connect the negative speaker wire to the negative (black) speaker terminal.



Limited Warranty

Your unit comes with a manufacturer's warranty covering any defects in materials and workmanship. Retro Manufacturing, LLC (collectively referred to as "the warranter"), at its option, will either (a) repair your unit with new or refurbished parts or (b) replace it with a new or refurbished unit. The warranty period starts from the original purchase date and is valid for the length of time indicated in the chart below. The decision to repair or replace will be made by the warranter.

During the "Parts" warranty period, there will be no charge for parts. You must mail in your unit during the warranty period at your expense. This warranty only applies to products purchased directly from Retro Manufacturing or an authorized dealer. This warranty is extended only to the original purchaser of a new product that was not sold "as is." A purchase receipt or other proof of the original purchase date is required for warranty service.

To handle a warranty issue, contact us at tech@retromanufacturing.com or 888.325.1555 for a Return Authorization (RA) number. A RA number must accompany all returns and warranty issues. Any product received without a RA number will be refused.
